Personal Statement: St. Michael's Episcopal Church is a big part of our life and an important part of my identity. Every day I attempt to live the words of our baptismal covenant: "To seek and serve Christ in all persons, loving my neighbor as myself" and "to strive for justice and peace among all people, and respect the dignity of every human being." My husband, Ric, and I raised our three children, Eric, Jessie and Katie as part of St. Michael's parish where they learned about God and the church through Catechesis of the Good Shepherd. In addition to attending Sunday School as they grew up, they sang in the children's choir, served as acolytes, participated in 4*5*6 Club, JHigh and SMUSH youth groups, and went on many mission trips. Our daughter, Jessie, assisted for two years in the Level One Catechesis Atrium and served as a Vestry youth representative for two years. In 2009 our daughter, Katie, won the "Kids with Heart" Award from Deer Park Towne Center and was able to designate the Katrina Care Campaign at St. Michael's to receive the \$500.00 she was awarded. Ric currently teaches and coordinates the confirmation process at St. Michael's, and over the years he has served on the Vestry, managed 4*5*6 Club with Nancy Holmes, taught 4th and 5th grade Sunday School with Laurie Michaels, and offered lectures on the history of the Anglican Communion/Episcopal Church. I include this family information here because my family is, has been, and continues to be an integral part of my spiritual life and journey in the Episcopal Church. Over the years, Ric and I have participated in Foyers, volunteered at the St. Michael's free Thanksgiving Day dinner, and served as coffee hour hosts. I earned certification for teaching Catechesis of the Good Shepherd for Level One with education from Fall 1994 to Spring 1996 and for Level Two in Summers 2002 and 2003. I have attended many ECW retreats, traveled on our church work trip to Haiti in Summer 2013, and have served on the Episcopal Diocese of Chicago Peace & Justice Committee since 2012. At St. Michael's, I have offered lectures on my trips to India, Tanzania, and evenings about Shakespeare, the man; A Midsummer Night's Dream; and Hamlet. On the diocesan level, I co-sponsored the 2018 April "Concert for a Cause" held at Church of Our Saviour in Lincoln Park to raise funds for Episcopal Peace Fellowship to send the Young Adult Delegation to General Convention this past July. I retired in May 2018 from teaching English and Peace Studies & Conflict Resolution at Waubonsee Community College, Sugar Grove, IL, but I continue my work for peace and justice as a board member of Episcopal Peace Fellowship and the Peace & Justice Studies Association. Currently, I usher at the 10:00 am service, and Ric and I chair our St. Michael's Peace & Justice Committee. We still spend time with the Syrian family, Mohammed, Duaa, Rital and Miral Alma Salma who were resettled in Chicago in Jan., 2017, by the United Nations High Commission for Refugees and RefugeeOne in Chicago, and co-sponsored by our church.
