

**Nominations for positions as Wardens, Vestry and delegates to the annual diocesan conventions are listed below with their bios. If you want to add your name to this list of candidates, please contact either of the wardens or Fr. Ralph. You must submit your name prior to February 22, 2026.**

**The motion to approve the Nominating Committee's Recommendations as is, and to publish these recommendations on February 9, 2026, was approved by the Vestry on February 5<sup>th</sup>.**

As the Nominating Committee, consisting of Bill Ferry, Sandy Rauschenberg and Ann Ryba:

We recommend that Liz Gabis be elected to a second one-year term as Senior Warden beginning February 1, 2026, and that her term as Senior Warden will end at the 2027 vote for a new Senior Warden.

We recommend that Bob Hoyler be elected to a second one-year term as Junior Warden beginning February 1, 2026, and that his term as Junior Warden will end at the 2027 vote for a new Junior Warden.

We also recommend extending the terms of all existing Vestry members, by class, for an additional year beginning February 1, 2026:

- a. We recommend that Lynn Mayberry, Wes Kimes and Sam Adams-Lanham be elected for one additional year on the Vestry and that their terms will end with the 2027 vote for new Vestry members.
- b. We recommend that Craig W. Anderson and Jeff Tolle be elected for one additional year on the Vestry and that their terms will end with the 2028 vote for new Vestry members.
- c. We recommend that Cathy Koehlinger, BJ Seagrist and Pat Okonek be elected for one additional year on the Vestry and that their terms will end with the 2029 vote for new Vestry members.

We recommend that Bob Wonder be elected to a 2-year term on the Vestry. His term will begin February 1, 2026, and end with the 2028 vote for new Vestry members. Bob is replacing Paul Carrubba who resigned when he moved.

We recommend that Suzanne Fleer, Jackie Kraus and Sam Adams-Lanham be elected as delegates to the 2026 Diocesan Convention.

Bios for all the candidates are included below:

### **Bob Wonder**
